Indonesia is one of the fastest growing countries in the world and the biggest economy in the ASEAN region. The economy has grown steadily at around 5 percent p-a since 2014. The Indonesian economy is growing at 5.1% and other macroeconomic indicators show a positive picture. The outlook is very good and currently Indonesia has a trade surplus of US \$ 11.8 trillion. To encourage accelerated and efficient development, infrastructure development is also being maximized. Indonesia is very serious about making itself competitive and creating a friendly investment climate, with 16 packages of policy reforms that since 2015 have reduced investment barriers and rules in various fields.

The government has worked hard on reforms, including removing fuel subsidies to free up funds to finance building roads, railways and ports. As the result of disciplined fiscal policy in 2017 Indonesia received investment grade ratings from Moody's, S&P and Fitch. Indonesia is ranked 73 among 190 economies in the ease of doing business, according to the latest World Bank annual ratings.
